Minutes of Kajiado Municipality Citizen Fora

Date: 14th May 2024

Venue: ACK Tenebo Hall

Opening Remarks:

The meeting commenced at 10:30AM with a word of prayer, introduction, and opening remarks from the Municipal Deputy Director Administration, Hellen Mumeita. She welcomed the citizens warmly, expressing gratitude for their presence and commitment to community engagement.

Min: 1/5/2024: Sensitization

The Municipal Deputy Director Administration sensitized the citizens on their power and the significance of citizen participation, as outlined in the Urban Areas and Cities Act of 2011. The officer in charge of citizen participation, Daniel Oltingidi, further elaborated on Gender Mainstreaming, emphasizing insensitivity across gender and social groups, and elaborated on the board's roles and responsibilities.

Min: 2/5/2024: Reading and confirmation of the previous minutes

Daniel read the minutes of the previous meeting held on 23rd November 2023. The minutes were proposed by the citizen fora Treasurer Sisina Kelempu and seconded by Antony Meikan.

Min: 3/5/2024: Solid Waste Management and Data Collection

The Municipal Manager presented the Municipal solid waste management policy draft, highlighting the causes of waste within the Kajiado Municipality and outlining the hierarchy of waste management from prevention to disposal. The policy framework, encompassing goals, objectives, and measures, were thoroughly discussed, with an emphasis on waste generation, handling, separation, storage, collection, transfer, transportation, and disposal. Registration and licensing of garbage collectors and compliance with legal frameworks formed a part of the discussion.

The discussion on solid waste management underscored the urgency of community-driven data collection initiatives and the need for heightened public awareness to achieve effective waste management solutions.

Min: 4/5/2024: Draft municipal By-Laws and Regulations

The Municipal Manager briefed attendees on drafted municipal by-laws and regulations. Plans for the review of existing by-laws to address pertinent challenges were also outlined by the Municipal Manager Kitengela.

Min: 5/5/2024: Municipal investment plan (World Bank projects)

The Municipal Manager provided insights into Phase II of the Kenya Urban Support Program (KUSP II), outlining key initiatives aimed at fostering urban development and enhancing infrastructure development within the Municipality. He informed the meeting that the expected funding will be used to for lighting projects that will enhance security and business enabling environment for the residents of Kajiado Municipality.

Min: 6/5/2024: Transferred Functions

The Municipal Manager updated citizens on transferred functions, and informed them that they had been fully operationalized. The Development Control Officer provided clarity on building approval procedures, emphasizing adherence to regulations and measures to address encroachment on riparian areas.

Min: 7/5/2024: A.O.B

- Municipal Manager Kitengelagave her remarks, encouraging them to take responsibility and vacate riparian areas, without waiting for adverse weather conditions or enforcement actions. She proposed future citizen fora be held across Kajiado municipality zones to enhance inclusivity and accessibility.
- Suggestions were made for streamlining agenda items and issuing early notifications for future fora, promoting efficient use of time and resources.
- Proposals were made to establish channels for disseminating information about citizen fora.

- Minimize presentation durations and give the citizens more time for debating on issues affecting them.
- Citizens emphasized the importance of receiving advance notices before the commencement of demolition works in riparian areas.
- vi. The forum highlighted incomplete roads overseen by the Kenya Urban Roads Authority (KURA). This signifies collaborative efforts toward enhancing the Municipality infrastructure.

Closing Remarks

The meeting, ended at 3:00pm with a word of prayer from one of the attendants. The Municipal Manager expressed gratitude to attendees for their valuable contributions and commitment towards municipal development.


