MINUTES OF KAJIADO MUNICIPALITY CITIZEN'S FORA HELD ON 23RD NOVEMBER 2023 AT ACK TENEBO HALL

Opening Remarks

The meeting started at 10.00 am with a word of prayer, introduction and opening remarks from the Municipal Manager. He welcomed the citizens to the forum and thanked them for finding time from their busy schedules to attend such an important occasion. The Manager then introduced the agenda of the meeting which was as listed in the letters of invitation.

Min: 1/11/2023: Introduction of the Municipal Board Members

The Manager gave a brief history of Kajiado Municipality and its inception and its principleagency relationship with the County Government. He mentioned that Kajiado Municipality has been in operation since its inception in 2018 and its management is done through an urban board. He further mentioned that the board is constituted by seven members appointed and approved as per the laid-out provisions of Urban Areas and Cities Act (UACA). The manager called on the Board Members present to introduce themselves.

Min: 2/11/2023: Municipal Status

The Municipal Manager pointed out that the Municipality operates through a Charter with laid out functions. He did a presentation explaining the functions transferred by the County to the Municipality to perform within its jurisdiction. The Manager also mentioned that the citizens have a very important role to play within the Municipality. He took them through a presentation describing their roles in the operations and management of the Municipality as detailed in UACA. The Manager, through a presentation, also touched on the Sustainable Urban Development, Urban Resilience, Citizen Delivery Charter and Constitution of a Citizen Fora.

Min: 3/11/2023: Climate Change - Climate Resilience Hubs

The Municipal Manager thanked the Municipal Board Members for being the first to have a committee on matters climate change. He said that the Municipality's dream is to have a Climate Resilience Hub and a team dedicated towards combating and addressing issues emanating from climate change in the Municipality. The hub to contain an engagement, relief and emergency shelter.

Min: 4/11/2023: Solid Waste Management

Family Bank as a partner of the Municipality was hailed for its efforts in managing waste by providing litter bins in strategic places within the Municipality. They also promised to continue with their support whenever called upon to assist.

The Municipal Manager and the citizens agreed on ratification of private garbage collectors within the Municipality. This will be the first step towards streamlining the sector for a more organized and coordinated manner of managing waste in the Municipality.

He informed the citizens of the Unit called Mazingira that has been very instrumental in managing waste within the Municipality since its inception. He urged the citizens to support this unit by cooperating with them while working on the ground.

The Sub-County Public Health Administrator took the meeting through the public health laws which guide on handling and managing solid and liquid waste. She informed the meeting that the department plans on community outreaches within zoned areas as a strategy towards managing waste within the Municipality. The citizens were also urged to be resilient and report cases of irresponsible and illegal dumping and/or burning of waste within the community.

NEMA Director requested to have a meeting with the board so as to assist in formulating strategies and measures to ensure proper waste collection and management within the Municipality.

Min: 5/11/2023 Accreditation, Registration of neighborhood Associations

The Municipal Manager informed the meeting that the Municipality will embark on an exercise to register neighborhood associations within the Municipality by issuance of Certificates. The certificates will attract a Ksh.500 fee.

Min: 6/11/2023: Budget and Work Plan

The Manager presented to the Citizens the Municipal status in terms of the projects so far undertaken within the Municipality. He also presented to them the Kajiado Municipality Annual Work Plan 2023-24 and took them through the proposed projects to be undertaken once donor funds are availed. He also made them understand that the donor funds also come with conditions as guided in the list of legible and non-illegible projects within the funding.

County Director of Planning informed the citizens that the Municipality was in the process of developing a Municipal Integrated Development Plan which is a basic requirement by law for any urban entity as stipulated in the Urban Areas and Cities Act, 2011. This is a tool that guides the Municipality, Development Partners, and Municipal Residents on the envisaged development agenda and prioritized projects for the realization of social economic transformation of urban setup. The plan will identify and focus on a number of programs and project proposals in every Municipal thematic area that are meant to drive the Municipality's socioeconomic transformation so as to accelerate the realization of quality and equitable development for the people of Kajiado Municipality.

Min: 7/11/2023: A.O.B

ii. Women Groups

Representatives from the Saina Women Group and Majaliwa Women Group, lauded the efforts of the Municipal Administration by pointing out the quick transformation the Municipality has experienced over the last three years owing to the various infrastructural projects that have been implemented. They, however, pointed out that the various newly constructed municipal roads are being misused and destroyed through the illegal dumping of solid and liquid waste in the stormwater drainages. They pointed out that this is a menace especially in residential areas such as Saina, Shapashina and Majengo Estates. They added that non-constructed and unfenced plots within the estates have been turned into illegal dumpsites. They requested the Municipality to enforce the fencing and securing of open plots by the owners in order to curb the menace.

They concluded by mentioning that their Community Based Organizations (CBOs) have been conducting cleanup exercises in the Municipal residential areas and they ready to partner with the Municipality to assist in the overall cleanliness of the town.

iii. Youth Groups

Representatives Youth Voice Africa, Ildamat Youth Group, Shapashina Youth Group thanked the Municipality for prioritizing and inviting Kajiado Town Youth to participate in the citizen Forum. They praised the Municipality for establishing and constructing the Kajiado Public Square, a public recreational urban green space. They mentioned that the facility has provided the youth with a place to converge and socialize while enjoying the available amenities. In light of this, they requested the municipality to consider them in the running and management of the Public Square.

iv. Tree Planting

The Manager mentioned that Kajiado Municipality is categorized as an Arid and Semi-Arid Land (ASAL) and has been impacted by frequent and prolonged drought seasons. He urged and encouraged the citizens to take advantage of this current rainy season to plant trees so as to mitigate the impacts of climate change.

v. Animal Control

It was also pointed out that roaming livestock within the Municipality have become a menace especially by threatening the efforts to grow and nurture trees within the town. It was agreed that a Municipal by-law needs to be put in place to curb the roaming of animals within the town.


Closing Remarks

The Municipal Manager once again thanked the members for attending the meeting and for their input. The meeting ended at 2.30Pm with a word of prayer.






Municipal Manager addressing the citizens




NEMA Director addressing the citizens




Public Health Officer addressing the citizens






